## Fastpath Security Designer for a Dynamics 365 Finance & Operations (F&O) Implementation

### ✔ Challenges

With locations in the U.S. and Asia, our customer designs and manufactures retail store fixtures and displays, perishable shelving hardware for supermarkets, electrical switches for computers, and is a third-party logistic solution for domestic and global shipments.

Our customer began implementing D365 Finance & Operations (F&O) less than a year before using Fastpath, now part of Delinea. The goal was to refine their user permissions during implementation to lower license costs and ensure appropriate access. Choosing not to solely rely on Microsoft's out-of-the-box security roles which were believed to grant excessive access to employees, they turned to Fastpath as their first solution. Their priority was to generate quick and accurate security reports detailing the roles they employed and assigned within the system.

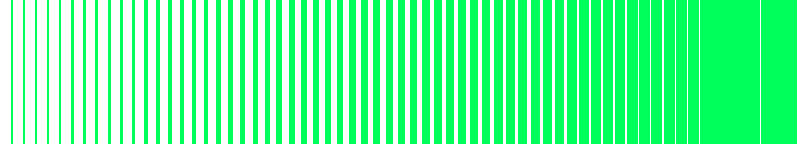
### ✔ Solution

Fastpath has detailed reporting capabilities that allow organizations to see users, roles, duties, and privileges. While the main purpose of these reports is security analysis, they do an excellent job of also laying out which Dynamics license types are required for the access being granted. Fastpath's Security Designer allows companies to review the potential risks associated with granting a user access and modifying roles, duties, and privileges before making the changes. Because Fastpath implementation only took a few days, our customer was immediately able to narrow security and lower the number of operational-level licenses required. Fastpath's Security Designer ensures that their employees have only the access they needed in D365 F&O for their job function and no extra access.
