## Norwegian Cruise Line Holdings

NCLH streamlines user access reviews and saves 300 hours annually with Fastpath

## Challenges

With a combined fleet of 32 ships, Norwegian Cruise Line Holdings Ltd. (NCLH) offers itineraries to approximately 700 destinations worldwide. As a publicly traded company, with over 41,000 team members across the globe, the need for automated User Access Reviews (UAR) was critical.

The NCLH IT compliance team was held responsible for SOX User Access Reviews, which included 450 unique reviewers, 14,000 users to be reviewed, and about 300,000 lines of access to be reviewed across their in-scope SOX business applications. This included the need to integrate with PeopleSoft, Salesforce and 12 other custom applications. NCLH is subject to SOX and PCI DSS compliance as well as GDPR. Performing these reviews using emails and spreadsheets was an extremely manual and time-consuming process that was prone to errors. This is when the CIO and Director of IT Compliance decided it was time to begin looking for a new solution for user access reviews.
