Microsoft's enforcement of license compliance for Dynamics 365 Finance & Supply Chain begins in 2025. With this new enforcement measure, businesses must ensure they are right-sized—paying for only the licenses they truly need. Once the August 30th deadline is reached, if users are licensed incorrectly they will be blocked from signing into the application.

Managing user access, roles, and licensing within ERP systems like Dynamics 365 Finance & Supply Chain (F&SC) is a complex, ongoing challenge. As employees take on new responsibilities or shift roles, their access needs change, requiring regular updates to access to ensure alignment with their job functions. 
